## Please Note: Information to Applicants

It is required that all applicants make an appointment with the Building Department when submitting an Application for an Amendment to the Restricted Area (Zoning By-law) or an Application for a Minor Variance. This is required so that all submissions can be reviewed to ensure they are complete. **Incomplete applications will not be accepted.** 

Applications must be completely filled in using dark blue or black ink only or typed – **do not use pencil**. The original copy of the application must be submitted to the Township. **A complete site (location) plan must be included with your application.** Requirements for the site (location) plan are included within the application. Please also note that should the Zoning Bylaw Amendment Application be approved by Council, the Township's Building Department may request confirmation of the building location from an Ontario Land Surveyor (OLS).

Once the application has been deemed complete, the application can be accepted and commissioned as required.

To arrange an appointment, please contact the Planning Department at Extension 264. Thanking you in advance for your co-operation.

**Please note:** If your property is located in the Chandos ward and is within the jurisdiction of the Crowe Valley Conservation Authority (CVCA), notice of your application will be forwarded to their office for their review and comments. They charge a fee for reviewing planning applications and they will collect it directly from you by mailing you an invoice. This checklist needs to be submitted with any application submitted. Should you determine that an archaeological assessment is required, we would encourage follow up discussion with the Township and Curve Lake to confirm specific requirements.

This application must be accompanied by a plan showing the dimensions of the subject land and of all abutting land and showing the location, size and type of all buildings and structures on the subject and abutting land as required within Question 26 of the application.
